**OFFICIAL RULES**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

Entry into the Lenovo “Cloud-a-Palooza” Giveaway (“Giveaway”) constitutes your acceptance of these Official Rules.

**DATES:** This Giveaway will be open solely during Lenovo’s “Cloud-A-Palooza”, taking place from March 22, 2022 at 10:00 AM EST until March 31, 2022, 10:45 AM EST (the “Entry Period”) and consisting of the following virtual briefings (each a “Briefing”):

**WHO MAY ENTER:** Open to all registered attendees of “Cloud-A-Palooza,” who (i) attend one or more Briefings, and (ii) are 18 years of age or older or have reached the age of emancipation in the jurisdiction in which they reside, whichever is greater. THIS CONTEST IS VOID TO RESIDENTS OF U.S. EMBARGOED COUNTRIES AND IS VOID WHEREVER RESTRICTED BY, WITHOUT LIMITATION, FILING OR REGISTRATION REQUIREMENTS, OR IS OTHERWISE PROHIBITED OR RESTRICTED BY LAW. Individuals employed by Lenovo Global Technology (United States) Inc. (“Sponsor”), its

affiliated companies, subsidiaries, and/or advertising and promotion agencies (collectively, "Giveaway Parties") at any time during the Entry Period, and members of their immediate family or persons living in the same household, are not eligible.

**HOW TO ENTER:** During the Entry Period, Eligible entrants ("Entrants") will be awarded one entry into the drawing per Briefing attended. Entrants who attend all four (4) Briefings will receive one additional bonus entry into the drawing. Entrants must follow all instructions provided by Sponsor to enter. All entries must be received by the close of the Entry Period.

**HOW TO WIN:** On March 31, 2022, immediately upon the end of the final Cloud-A-Palooza Briefing, the Entry Period will be closed in its entirety. On or about April 8, 2022, five (5) winning Entrants from the pool of eligible entries will be randomly selected to win a Prize, for a total of five (5) total Giveaway winners. All winners will be notified by Sponsor via email.

**Limit one prize per person.** Note: You are not a winner of any prize until you have been verified as a winner by the Sponsor. Decisions of Sponsor are final in all matters relating to this Giveaway.
